Contract between Wikimedia Italia and Wikimedia Sverige for the project Connected Open Heritage

§ 1 Contracting entities and signatories

§ 2 The extent of the collaboration and the relationship between the contracting parties

Between Wikimedia Italia and Wikimedia Sverige an agreement has been reached regarding the implementation of a collaboration with regards to the project Connected Open Heritage, hereafter called the Project, in according with *Appendix 1: Project Description – Connected Open Heritage*. The goal of the project is to create and preserve knowledge about, and increase the awareness and willingness to preserve, the global cultural heritage – through freely licensed digital information.

Wikimedia Sverige is the project owner and contact with the funding body, PostkodLotteriets Kulturstiftelse (the Culture Foundation of the Swedish Postcode Lottery), hereafter called the Funding Body. Wikimedia Italia is a collaboration partner and receives their project related funding through Wikimedia Sverige.

§ 3 Wikimedia Sverige's commitment and responsibility

Wikimedia Sverige commits to financing Wikimedia Italia's part of the implementation of the Project to a maximum total of 100,000 SEK, in accordance with *Appendix 2: Financing Plan*.

§ 4 Wikimedia Italia's commitment and responsibility

Wikimedia Italia commits to undertaking the following, within the Project:

- Preparation and support for the mass upload of the images from Palmyra from the archaeological group of Rome (which include working with the metadata, translations, categorization etc.).
- Organizing a photo exhibition with the theme of cultural heritage that is in danger and how digital preservation can help (with identifying images, writing the texts, creating a brochure, finding venues for the exhibition etc.). The exhibition will be shown in at

- least three countries, including Sweden and Italy. In addition there will be an online version of the exhibition.
- Any other unforeseen tasks in the context of Wikimedia Italia's areas of responsibility
 within the Project which may arise and require action for the Project to reach its
 overarching goal and purpose, within the limits of the assigned budget.

§ 5 Handling the transfer of funds

Wikimedia Sverige transfers funds to Wikimedia Italia at each payment date as specified in *Appendix 3: Payment Plan*. § 6 Reporting

Wikimedia Italia shall report on the progress of the Project in accordance with the following:

- 1. Monthly reports to Wikimedia Sverige in accordance with *Appendix 4: Internal Project Reports*.
- 2. Short bi-weekly meetings via telephone, video conference or in person with Wikimedia Sverige for coordination. The weekly meeting can be cancelled due to special circumstances (e.g. longer travels, holidays etc.).
- 3. Support Wikimedia Sverige with the reporting to the Funding Body, consisting of two Interim Reports and one Final Report. The Interim Reports shall be written in a narrative form and include detailed information about the progress of the activities included in the Project Plan including, but not limited to, the achieved results to date, any deviations, a forecast for the period until the next Interim Report or the Final Report as shown below. The Interim Reports shall be submitted in the format described in *Appendix 6: Template for Interim Report* and be made available to Wikimedia Sweden in time for their report to the Funding Body in accordance with the following:
 - o Interim Report 1: before 2016-06-10.
 - o Interim Report 2: before 2016-12-09.
 - Final Report: before 2017-09-15.

§ 7 Ownership of the results

Results produced as part of the project are owned by Wikimedia Sverige and will by Wikimedia Sverige be licensed in accordance with *Appendix 5: Creative Commons* -

Attribution - ShareAlike 4.0 (CC BY-SA 4.0) which gives Wikimedia Italia rights of use of the results on the same terms as any other party.

§ 8 Changes

Changes to this contract can only be done in writing and by agreement by both parties.
